**Senator Bill Cassidy, MD**  
Louisiana

**Dr. Bill Cassidy** is the United States Senator for Louisiana.

Bill grew up in Baton Rouge, Louisiana, and attended Louisiana State University (LSU) for undergraduate and medical school. In 1990, Bill joined LSU Medical School teaching medical students and residents at Earl K. Long Hospital, a hospital for the uninsured.

During this time, he co-founded the Greater Baton Rouge Community Clinic, a clinic providing free dental and health care to the working uninsured. Bill also created a private-public partnership to vaccinate 36,000 greater Baton Rouge area children against Hepatitis B at no cost to the schools or parents. In the wake of Hurricane Katrina, Bill led a group of health care volunteers to convert an abandoned K-Mart building into an emergency health care facility, providing basic health care to hurricane evacuees.

In 2006, Bill was elected to the Louisiana State Senate.

In 2008, he was elected to the United States House of Representatives to represent Louisiana's Sixth Congressional District.

In 2014, he was elected to the U.S. Senate. He serves on the Finance Committee, the Health, Education, Labor, & Pensions Committee, the Energy and Natural Resources Committee, and the Veterans Affairs committees.

Following his successful efforts to lower the cost of health care, secure coastal restoration projects to protect Louisiana families from natural disasters, reform our nation's mental health system, and secure many other legislative accomplishments, Bill was reelected in 2020 to his second term in the U.S. Senate.

Bill is married to Dr. Laura Cassidy, and they have three children. Laura is a retired general surgeon specializing in breast cancer. She helped found a public charter school to teach children with dyslexia. Bill, Laura, and their family attend church at the Chapel on the Campus.

### **Carolyn C. Carpenter, MHA, FACHE**

**Carolyn Carpenter** is currently President of Johns Hopkins National Capital Region (NCR). In this newly created role, Carpenter leads all hospital-based and community-based ambulatory sites across the National Capital Region on behalf of Baltimore-based [Johns Hopkins Medicine](#) (JHM), including Sibley Memorial Hospital and Suburban Hospital. She is responsible for the strategic growth and operational performance of all current and future JHM entities and initiatives within the NCR which encompasses Washington, DC and the adjacent counties in Maryland and northern Virginia.

Prior to joining Johns Hopkins, Ms. Carpenter served as the President of Sentara Norfolk General Hospital and Corporate Vice President of Sentara Healthcare. These roles included leading a 525-bed community teaching hospital and Level I Trauma Center as well as serving as the system executive for the Sentara Cancer Network and Sentara Cardiovascular Services spanning twelve hospitals in Virginia and North Carolina.

Ms. Carpenter came to Sentara after working at Duke Health for twenty years. During that time, she served in a variety of capacities including Chief Operating Officer of Duke University Hospital, Associate Dean of the Duke School of Medicine, Associate Vice President of Oncology Services for the Duke Health System, and Associate Chief Operating Officer for Medical/Surgical/Critical Care Services. Ms. Carpenter led the creation of the Duke Cancer Institute, the first of its kind at Duke that brings together clinical, research, and basic science operations into one organization. Before joining Duke, she held positions as Academic Administrator for the Department of Medicine at the Hospital of the University of Pennsylvania and Senior Management Analyst at the Medical College of Virginia Hospitals.

Ms. Carpenter received her B.A. at the University of Pennsylvania and her MHA from Medical College of Virginia. She completed an administrative fellowship at Duke. She is a Fellow of the American College of Healthcare Executives and an Adjunct Assistant Professor at the University of North Carolina at Chapel Hill School of Public Health. In 2016-7, Ms. Carpenter was among the inaugural class of Carol Emmott Fellows, a select fellowship for women leaders aimed at empowering female health executives to bridge the gender gap in the C-suite and transform health care.

His research has spanned projects that have examined the quality of outpatient GI consultation notes, improving patient access through implementing a set of discharge criteria after endoscopy, studying the informed consent process in endoscopy education classes, and improving endoscopy center operational efficiency using time and motion studies and simulation modeling. Dr. Day is President Elect of the Association of American Indian Physicians. He previously was Chair of the ASGE Quality Assurance in Endoscopy Committee and currently serves as Councilor on the ASGE Governing Board.
